

PHILADELPHIA / CENTER CITY RENTAL INSTRUCTIONS

Dear Prospective Tenant:

If you are interested in renting an apartment from *Vert Properties Inc. (VP)*, please follow the following sequential steps:

- 1. <u>Application Fee</u> If you are interested in any of the apartments you have been shown or have seen online please be prepared to submit a \$50.00 application fee per applicant made payable to *Vert Properties, Inc.* You can hand the fee(s) to the VP rep that showed the apartment (preferred), hand deliver to our offices in Mantua, NJ, or mail fee(s) to our office (expedited delivery is preferred) to *Vert Properties Inc. 591 Mantua Blvd, Suite 201, Sewell, NJ 08080*.
- 2. <u>Application</u> –Review, fill out and sign an application, which can be done online via an email link from our corporate office. If you prefer to complete a paper application then simply go to our website, <u>www.vertproperties.com</u> to download a copy or request one via email to <u>info@vertproperties.com</u>. Please indicate that you have handed in your application fee(s) and request an application. Once the application is completed and signed you can scan and send back to <u>info@vertproperties.com</u>.

Note: Please make sure your application fee(s) are in the possession of a VP representative to prevent delays in approval.

- 3. Reserving Apartment To hold an apartment a security deposit of one (1) month's rent is required. We encourage prospective tenants to prepare a check for the security deposit to deliver immediately to reserve the unit (the check should be made payable to *Vert Holdings, LLC*). If you are not approved for some reason, your deposit will be returned to you or shredded at your direction. If you are approved, then the security deposit will be applied and the unit is taken off the market and reserved for you. If you fail to enter into a lease following approval then the security deposit is forfeited as liquidated damages.
- 4. <u>Lease</u> Once the approval process is complete, you will receive a lease to review and sign, at which time first and last month's rent is required before move-in.
